## Daycare Agreement

The Staff agrees to exercise due diligence and reasonable care. And to keep the premises sanitary and properly enclosed. All pets are handled or cared for by the Daycare Staff without liability on the Staffs part for loss or damage from disease, theft, fire, death, escape, injury or harm to person's, other pets, or property by said pet, or from other unavoidable causes, due diligence and reasonable care having been exercised. Should any daycare and/or boarding pets become ill or seem to be in need of medical consideration, the Staff reserves the right to administer aid and/or to use any veterinarian. Any expense so incurred shall be paid by the owner of said pet in addition to other Fees listed in this agreement.

Owner agrees to pay the rate for daycare and/or boarding in effect on the date the is checked out. Prices are subject to change at any time, without notice. No daycare or boarding pets will be released until all charges are paid in full. Late cancellation fees may also be applied for reservations canceled less than 4 days before the scheduled reservation. "Paws in The woodlands" shall have, and is hereby granted, a lien on the pet for any and all Unpaid charges resulting from daycare or boarding at the facility. Cancellation with less than 4 days will be charged 2 full days. Holiday reservations require a 2 day, non refundable deposit.

Owners shall remain liable for complete daycare/boarding bill as well as other charges incurred in the care and Maintenance of said pet listed on the contract. The owner further agrees to be solely responsible for any and all acts or behavior of said pets while in the care of the facilities staff. The owner of the pet agrees to pay reasonable attorney fees incurred by "Paws in The Woodlands" facility and/or Staff in the collections of any daycare/boarding services Other charges incurred by the owner of the pet.

The pet must be current on the following vaccinations: distemper, Parvo, Brodetella and Rabies. Pet must also be Spayed or Neutered and on a Heartworm and Flea/tick preventative. Valid proof of vaccinations must be presented before the pet can be dropped of for daycare/boarding. Owner also agrees to maintain vaccinations and keep the Staff Appraise of any updates. The Staff reserves the right to refuse any pet.

Owner agrees that the pet will be picked up by the owner or a pre-approved owner's agent by 9:00 PM. Late charges may be assessed for dogs picked up beyond 24 hours from time of drop off.

Owners agree that their pet may be photographed or videotaped. "Paws in The Woodlands" shall be the exclusive owner to the results of all proceeds of such tapings, photography and recordings with the rights, through out the word, an unlimited number of times in perpetuity, to copyright, to use and to licence to others in any manner. The Owner further agrees that their pet may be used in any and all media promotion, advertising, sale, publicizing and exploitation of "Paws in The Woodlands" facility.
